Aux Notes Summarized:

Aux Liaison Cindy Demers: Cindy reports that Cindy Lou took notes from the Auxiliary meeting at Nationals this year. Details as follows: There are now 48 Aux State Reps. There are 41 Aux Chapters. Zero bylaw changes were made at National's this year. There are 4,617 Auxiliary Members, 130 Widows, and 836 Life Members. The Auxiliary grew by 715 new members from 2022-2023. 101 scholarships were awarded with 2 trade school applicants.

Old Business:

Chapter Commander informs the membership that the term "colors" has been voted acceptable at Nationals this year. The other three amendments failed.

Doug Stone reports the Scholarship presentation went well. The recipient was from Hancock and she wore a CVMA t-shirt in a photo in thanks for the scholarship.

New Business:

Chapter Commander mentions that Sergeant at Arms Kim Davis is in need of a new chair after his "high speed wreck". The cost would be \$799.00. Ed La Ford made a motion for the Chapter to cover this cost. Jack seconded. The motion passed with no objections.

Chapter Commander mentions Treasurer Tim Fortin is monitoring our accounts to ensure we do not go over the limits for a nonprofit, and determine the amount that it is.
